

Lockout notice applying to Aarhus University employees employed under the AC (Danish Confederation of Professional Associations) multi-union collective agreement

Lockout notices applying to employees who are members of Danish Confederation of Professional Association (AC) unions at Aarhus University are listed in the table below. Owing to the need for emergency staffing, a few employees may be exempted from the lockout notice. These employees will be notified directly by Aarhus University as soon as possible.

The lockout is scheduled to commence on 10 April 2018 at the beginning of the day (00:00 hours). The conciliation board has the authority to postpone the date on which the lockout commences. If the negotiating parties conclude new collective agreements, the lockout will not take place.

The lockout will not apply to the following employees employed under the AC (Danish Confederation of Professional Associations) multi-union collective agreement

Administrative Centre, Health: Everyone at Building Services and IT Support
Administrative Centre, Health: Two named employees have been exempted to provide emergency services (IT and buildings)
Department of Biomedicine: Five named employees have been exempted to monitor research equipment and biological material
Department of Forensic Medicine: The entire Department of Forensic Medicine
Department of Dentistry and Oral Health: One named employee has been exempted to monitor research equipment
Administrative Centre, Arts: Everyone at Building Services and IT Support
Administrative Centre, Aarhus BSS: Everyone at Building Services and IT Support
Department of Engineering: Biogas Foulum, one named employee
International Centre for Research in Organic Food Systems: Emergency staffing to protect valuable research which would be difficult to replace
Administrative Centre, Science and Technology: Emergency staffing for IT and buildings, two named employees
Science Museums: Emergency staffing for the greenhouses, one named employee
Department of Environmental Science: 11 named employees
