Lockout notices applying to employees of Aarhus University under OAO- the Organisation of Public Employees are listed in the table below. Because of the need for emergency staffing, a few employees may be exempted/released from the lockout notice. These employees will be notified directly by Aarhus University as soon as possible.

The lockout is scheduled to commence on 10 April 2018 at the beginning of the day (00:00 hours). The conciliation board has the authority to postpone the date at a later point. The lockout will not take place in the event that the negotiating parties conclude new collective agreements.
