TIL ORIENTERING

Skemaerne for forårssemestret 2023 er offentliggjort

Studerende har hermed mulighed for at orientere sig i en uddannelses ændrede struktur og tankerne bag ændringerne, før de søger optag og deltager i vejledningsarrangementer i kommende tid.

EVU undervisningsmiljøundersøgelse – udvidet spørgeramme E22

Uddannelsesudvalget har besluttet at gennemføre en EVU-pilotundersøgelse bestående af:

- en kortlægning af de studerendes vurdering af studiemiljøet (survey),
- en kortlægning af de studerendes vurdering af sammenhængen mellem uddannelsen og de studerendes arbejdsliv (survey)
- en registerbaseret kortlægning af EVU-studerendes arbejdsmarkedstilknytning (registerdata).

De studerendes vurdering af studiemiljøet udgør grundlaget for at udarbejde den lovpligtige undervisningsmiljøvurdering (UMV) på EVU-uddannelserne, der ikke var med i den store UMV i E21.

Spørgerammen tager udgangspunkt i de spørgsmål, der allerede stilles på EVU-uddannelser på Arts, men udvides i E22 med spørgsmål relateret til de studerendes oplevelse af områder på studiet, hvor AU er forpligtet til at indsamle viden (det fysiske, psykiske og æstetiske).

Resultaterne af undervisningsmiljøvurderingen er tilgængelige i foråret 2023, og afdelingerne har herefter i samarbejde med uddannelsesnævnene til opgave at drøfte resultaterne og udpege, hvis der er områder, hvor der er behov for en indsats for at udvikle og sikre et godt undervisningsmiljø for EVU-studerende.

Indsatserne skal efter [lovkrav](#) gøres offentligt tilgængelig i form af en handleplan. Der oprettes en hjemmeside til formålet, lig den der er for det [ordinære område](#).

Tid til første job – ny Power Bi rapport

En ny emnerapport '[Tid til første job](#)' er nu tilgængelig i Power BI. Rapporten viser, hvor lang tid der går fra de studerende har fuldført deres uddannelse til, at de har fået deres første fuldtidsjob. Data stammer fra UFM's datavarehus og omfatter resultater for alle dimittender fra universiteterne samt professionshøjskolerne og for uddannelsestyperne professionsbachelor og kandidat. Det betyder, at det er muligt at sammenligne på tværs af institutioner, men også at se resultater for den enkelte uddannelse.

VIGTIGE DEADLINES

Indmelding af opfyldte forudsætningskrav til vintereksamen

Forudsætningskrav fylder i øjeblikket meget på Arts, fordi der pågår et arbejde i alle fagmiljøer om at fjerne forudsætningskrav fra de eksisterende studieordninger.

Forudsætningskravene forsvinder dog først fra og med efteråret 2023 og det betyder, at studerende ved den kommende vintereksamen samt sommereksamen 2023 skal opfylde forudsætningskrav som hidtil og at underviserne skal melde ind til UVAEKA, hvilke studerende der har bestået/ikke bestået.

Fristen for indmelding ved vintereksamen er **9. december**.

The degree programme diagrams under the 2023 academic regulations are now available.

You will find them in the study guide: www.bachelor.au.dk, www.tilvalg.au.dk and www.kandidat.au.dk, along with a short text describing the changes being considered in the current revision of the academic regulations.

This gives students the opportunity to familiarise themselves with the structure of a degree programme and the reasons for the changes before they apply for admission and take part in counselling events in the months ahead.

The full academic regulations will be published on 1 March 2023.

Additional questions in the FE teaching environment assessment

The Committee on Education has decided to carry out an FE (further education) teaching environment pilot assessment. It will consist of:

- Mapping students' assessment of the teaching environment (survey)
- Mapping students' assessment of the correlation between their degree programme and working life (survey)
- A register-based mapping of the labour-market affiliation of FE students (register data).

The students' assessment of the teaching environment forms the basis for the statutory teaching environment assessment (UMV) of the FE programmes, which were not included in the extensive autumn 2021 UMV. The question framework is based on the questions previously asked in the Arts FE programmes, but from the autumn semester 2022, questions relating to students' experience of the teaching environment are included. They concern the areas on which AU is obliged to collect data (the physical, psychological and aesthetic teaching/study environment).

The results of the teaching environment assessment will be available in the spring of 2023, and in collaboration with the degree programme boards, the departments are responsible for discussing the results and identifying any areas in which special efforts are needed to develop and ensure a good teaching environment for FE students.

It is a [legal requirement](#) that such efforts are made publicly available in the form of an action plan. For this purpose, a website will be created similar to the one for the [full-time degree programmes](#).

The School of Communication and Culture: 8 registered, 3 new courses, 5 courses offered again - all internationalisation courses

The School of Culture and Society: 8 registered, 4 new courses, 4 courses offered again - all internationalisation courses

The Danish School of Education: 2 registered, 2 courses offered again - 2 elective courses in the Master's degree programme in educational sociology, 1 of which will be conducted in Emdrup and 1 in Aarhus.

“Tid til første job” - new Power BI report on the time between graduation and employment

A new topic report [“Tid til første job”](#) is now available in Power BI. The report shows how long it takes for graduates to get their first full-time job. The data are from the data warehouse of the Ministry of Higher Education and Science. They include all university and university college graduates of professional Bachelor's degree programmes and Master's degree programmes. This makes it possible to compare data for each individual degree programme and across institutions.

IMPORTANT DEADLINES

Inform UVAEKA of students' compliance with winter exam prerequisites

Arts is currently focusing on exam prerequisites. The academic environments are revising the existing academic regulations to remove exam prerequisites.

However, exam prerequisites are not phased out entirely until the autumn semester of 2023. Students taking the upcoming winter exams and the summer exams in 2023 still need to meet the stipulated exam prerequisites. Members of teaching staff are asked to send a list to UVAEKA of the students who have met/not met the prerequisites.

In relation to the upcoming winter exams, the deadline for doing so is **9 December**.
