Reducering i antal af forudsætningskrav fra efteråret 2023

Efter en længere proces med inddragelse af alle fagmiljøer vil der fra efteråret 2023 ske en reducering i antallet af forudsætningskrav på Arts. Det betyder, at der fremover kun vil være et mindre antal kurser, der har et forudsætningskrav. Det vil fremgå tydeligt af studeordning (pr. 01.09.2023) såvel som kursuskatalog, hvis der er forudsætningskrav på et kursus. Undervisere på kurser med forudsætningskrav vil desuden modtage alt den nødvendige information om indhentning af forudsætningskrav fra eksamensadministrationen umiddelbart efter studiestart.

Studiestartsprøver afvikles i efteråret 2023

Studiestarten nærmer sig, og det betyder også, at det snart er tid til at afvikle studiestartsprøver. Studiestartsprøverne er uden fagligt indhold - formålet er at afgøre, om de studerende reelt er startet på deres uddannelse, og det viser de ved at deltage i prøven.

På bacheloruddannelserne afvikles studiestartsprøverne i løbet af undervisningens første uger og kan have forskellige former. På kandidatuddannelserne afvikles de af UVAEKA og består af et spørgeskema, der skal udfyldes, og et dokument, der skal afleveres i Digital Eksamens. UVAEKA sender informationsmails ud omkring de to versioner af studiestartsprøven.

Semesterkoordineringsmøder afholdes i september

Et nyt semester betyder også en ny omgang semesterkoordineringsmøder mellem de 23 afdelinger på Arts og UVAEKA. På møderne udveksles diverse orienteringer, der evalueres på de overståede planlægningsprocesser og drøftes opmærksomhedspunkter fremadrettet. Afdelingerne vil modtage mødeinvitationer i løbet af august.

Antal afleverede specialer d. 1. juni 2023

1. juni var den store specialeafleveringsdag. UVAEKA har lavet en opgørelse over, hvor mange studerende der har afleveret deres speciale. Opgørelsen tager udgangspunkt i de studerende, som havde afleveringsfrist d. 1. juni 2023 på 1. prøveforsøg. På IKK afleverede 78% af de studerende, på DPU afleverede 70%, og på IKS afleverede 67%. I alt afleverede 73% af de studerende på hele Arts, hvilket er en stigning i forhold til sidste år, hvor 71% afleverede.

USEFUL INFORMATION

New head of studies administration at Arts

Jesper Qvistgaard has agreed to become the new head of studies administration at the Faculty of Arts. He took up the position on 1 August. Fewer prerequisites from autumn 2023

After a lengthy process involving all departments, the number of prerequisites at Arts will be reduced from autumn 2023. This means that in future, only a small number of courses will have prerequisites. If students need to comply with any prerequisites to take a certain course, this will be clearly stated in the academic regulations (as of 1 September 2023) as well as the course catalogue. Staff who teach courses with prerequisites will also receive all the necessary details on how to obtain information about prerequisites from the exam administrators immediately after the commencement of studies.

Commencement of studies exams in autumn 2023

The new semester is approaching, which also means that the commencement of studies exams will soon be taking place. The commencement of studies exams are not academic exams. The purpose of the exams is to find out whether the students have actually started their degree programme, which they can prove by taking the exam.

On the Bachelor's degree programmes, the commencement of studies exams take place during the first weeks of the programme, and there are various types of exams. The exams on the Master's degree programmes are organised by UVAEKA, and to take the exam, students must complete a questionnaire and submit a document in the Digital Exams system. UVAEKA will send out emails with information about the two versions of the commencement of studies exam.

Semester coordination meetings will be held in September

A new semester means a new round of semester coordination meetings between the UVAEKA team and the 23 departments at Arts. At the meetings, participants give each other updates, evaluate the completed planning processes and discuss future areas of focus. The departments will receive meetings invitations in August.

Number of Master's theses submitted on 1 June 2023

1 June was the day when a lot of students submitted their Master's thesis, and UVAEKA has created an overview of the exact figures. The overview includes all students whose submission deadline was 1 June 2023 (first examination attempt). At the School of Communication and Culture, 78% of the students submitted their Master's thesis; at DPU, 70% submitted their thesis, and at the School of Culture and

Society, 67% submitted their thesis. A total of 73% of the students at Arts submitted their Master's thesis, which is an increase compared to last year (71%).

Thesis form

The Master's thesis form to be used in the coming semester has been updated. Now it contains a section in which the students must indicate whether they intend to write their Master's thesis in collaboration with a company/organisation. The change was made based on a request from the departments and discussions in the Arts Forum for Education. The aim is to ensure that the supervisors are informed early in the process if some students intend to write their Master's thesis in collaboration with a company/organisation.
