Beløbet vil automatisk blive udbetalt med månedslønnen i januar det følgende år.</p>	<p>What is the senior bonus (brief summary) It means that employees (<i>not if paid by the hour</i>) has right to receive a yearly senior bonus of 0.8 percent (equivalent to 2 days yearly) of the usual yearly salary from the year in which you turn 62 years old. The amount will automatically be paid out with the January salary the following year.</p>
